FOR OUR MEDICARE MEMBERS HEALTH PLAN DEDUCTIBLES WERE RESET IN JANUARY

Medicare Part B deductibles were reset on January 1, 2023. The deductible for Medicare B decreased \$7 from \$233. to \$226. and the Emblem Health/GHI Senior Care deductible remained \$50. totaling \$276. Please remember that the deductible applies to the first doctor or doctors who have submitted claims to Medicare. This may or may not have been the first doctors that you have seen in 2023. The part of the \$276. deductible that you pay when you visit a doctor will depend on the doctor's service and what Medicare allows for the service.

The likelihood is that it will be less than the full amount of the deductible. You will pay the amount that is left at future doctor's visits.

MEDICARE PREMIUMS WERE ALSO RESET IN JANUARY

The standard Medicare Part B monthly premium will be \$164.90. Those whose Medicare Adjusted 2021 taxable income was greater than \$97,000. if they filed individually or \$194,000. if they filed jointly, will pay a Part B and a Part D surcharge which is called the Income Related Monthly Adjustment Amount or IRMAA in addition to the standard amount. This amount is based on their 2021 taxable income. IRMAA Part B deductions are reimbursable while IRMAA Part D deductions are not reimbursable.

UNDERSTANDING YOUR PRESCRIPTION PLAN AND RELATED

EXPENSES IF YOU ARE ON MEDICARE

In 2023 you must have \$7,400. in true out of pocket expenses (TROOP) before catastrophic coverage kicks in. When this occurs you only have to pay 5 percent of the cost of your prescription drugs. This 5 percent is reimbursable by the CSAWelfare Fund up to a yearly maximum of \$5,000. There is no deductible. You must



submit proper documentation to the Welfare Fund to obtain this reimbursement. Call them at 212-962-6061 if you need more information.

The pension deduction, for those enrolled in the GHI Enhanced Medicare Part D plan associated with the Senior Care health plan will remain at \$125.00 per person per month. As part of the Health Care Reform legislation passed in 2010, manufacturers provide a point-of-sale discount. As a result, the "donut hole "is eliminated and you will pay 25 percent of the cost of generic medications and 25 percent of the cost of brand name medications until you reach the catastrophic stage. The value of the manufacturer's discount is credited to you as the "amount others paid on your behalf" shown on your monthly report from Express Scripts/Emblem Health which is titled "Your Monthly Prescription Drug Summary."

In 2023, those who are subject to an IRMAA assessment on Medicare B will continue to be assessed on Medicare Part D. This is in addition to the plan premium which is deducted from your monthly pension check.

PRESCRIPTION DRUG REIMBURSEMENT FOR NON-MEDICARE RETIREES

Reimbursement by the CSA Welfare Fund of drug co-payment expenses is 80% after the annual \$100 deductible, with an annual maximum of \$10,000 for members enrolled in a city basic health plan with the optional rider for prescription drugs. This benefit is separate from the CSA Welfare Fund's Supplemental Medical or the Catastrophic Medical benefit. This also applies to eligible spouses (or registered domestic partners) who have their own prescription drug plan as well. A description of the spouse/partner plan should be submitted with claim submission in order to facilitate determination of allowable benefit.

If the spouse/partner is a retired UFT member with membership in SHIP, co-payments are to be submitted to SHIP first. Submit an explanation of benefits or

denial from SHIP for applicable coordination of benefits. The CSA Retiree Chapter will automatically pay the member 20 percent of the payment from the CSA Welfare Fund with no deductibles, no co-pay and no maximum.

MEDICARE RETIREES, MEDICARE B REIMBURSEMENT AND IRMAA

If you are on Medicare, you should have received your 2023 Benefits Letter from Social Security at the end of November 2022. Put this letter in a safe place if you file for IRMAA. It is a good idea to have an IRMAA file. You will need this letter in April of 2024 when you file for your 2023 IRMAA.

The first page of the SSA letter contains 4 bullets. The first one shows how much your SS benefit for 2023 is before deductions, providing you are collecting Social Security. The second bullet shows the 2023 deductions for Medicare Part B for the standard amount and for IRMAA. If you are not eligible for 2023 IRMAA, the IRMAA deduction should be 0. The third bullet shows the 2023 deduction for Part D IRMAA. If you have an IRMAA deduction for Part B then you will also have one for Part D. Remember Part D IRMAA is not reimbursable. The fourth bullet lists your SSA benefit amount after all deductions.

In April of 2023 you should automatically receive the basic Part B Medicare reimbursement. It should be \$ 2,041.20 which is \$170.10 x 12. This will be deposited to the same account as your monthly pension.

In April or May of 2023, IRMAA cover letters should be available at the OLR (Office of Labor Relations) website www.olr.nyc.gov and the CSA Welfare Fund website www.csawf.org. For this website go to Medicare Reimbursement. If you are unable to download the IRMAA cover letter for 2022, contact Stanley Wilson at 917-692-2942 and request that a cover letter be mailed to you.

In addition to a signed cover letter you must also submit copies of your Social Security Benefits Letter for 2022 AND your SSA-1099 for 2022. If you can not

locate these documents call Social Security at 800-772-1213 or visit your local Social Security office or go to www.ssa.gov to obtain them.

INCREASE AND CHANGE IN THE CSA WELFARE FUND OPTICAL BENEFIT



As of January, 2023, the yearly optical benefit is \$150. The CSA Retiree Chapter remains at \$65. There is also a change in the way you file a claim for the optical benefit. You will no longer get an optical voucher from the CSA Welfare Fund.

The CSA Welfare Fund has contracted with General Vision Services (GVS) to provide a comprehensive plan that covers a through vision care examination, including dilation, cataract, and glaucoma screenings when required.

The GVS frame collection is offered at most in-network locations in the greater New York area. Frames are covered by the plan at no cost to you up to a retail value of \$200. A \$150 allowance applies for most frames not in the collection.

Single vision, bifocal or trifocal lenses are all included along with lens options such as GVS progressives as well as lenses with scratch resistant and ultra-violet coating. Alternatively, members are eligible for up to a six month supply of disposable contact lenses covered by the plan (2 week or planned replacement) or a \$150 credit toward contact lenses not covered by the plan.

GVS provides services at hundreds of locations in their network throughout the greater metropolitan New York area including Cohen's Fashion Optical and Sterling Optical as well as at malls and major shopping centers with expanded hours of coverage, seven days a week.

A combined dental and vision card was sent to you to help validate your benefits through both the GVS network and the ASO network for dental benefits. The dental benefit remains the same and will continue to operate separately from this new vision benefit.

TO ACCESS YOUR OPTICAL BENEFIT USING A GVS PROVIDER:

Go to www.generalvision.com and register OR Download the GVS app. When prompted, enter your benefit number which is <u>6025</u> for retirees. You can view your optical plan, schedule appointments for services, and use the zip code locater to find a participating provider. OR Call GVS at 888-346-1802 to ask questions and/or make an appointment.

TO ACCESS YOUR OPTICAL BENEFIT NOT USING A GVS PROVIDER:

All direct reimbursement claims starting in 2023 will be processed by GVS. Any optical service provided by out-of-network providers must be sent to GVS with a claim from and paid itemized receipt. Call GVS at 888-346-1802 to obtain a claim form. Ask your provider to fill out their section of the claim form. If the claim form asks for your Social Security number only provide the last 4 digits. Mail the claim form and the receipt to GVS at 520 8th Ave., New York, NY 10018.

TRS UPDATES



You should have received your TRS 1099 Forms for 2022 in January 2023. They are also available in the secure section of the TRS website which is www.trsnyc.org.

Log in with your username and password and then go to Documents. If you did not receive your TRS 1099's in the mail or if you need an additional copy of a 1099 form, log in to the secure section of their website to access the forms. Please note that TRS representatives cannot provide tax advice, so contact a tax advisor for tax-related questions about your 1099 forms. TRS must periodically

ask retirees to complete and return the" Retirement Allowance and Verification Form" to ensure that their information is complete and current.

Any of the following is considered acceptable documentation:

- 1. The "Retirement Allowance Verification Form "with page 3 completed and signed and page 4 blank along with:
- A readable copy of your driver's license, passport, green card, or other government- issued ID or a recent Medicare or prescription statement; AND
- A photograph of you with a newspaper where you and the date of the newspaper are clearly visible.
- 2. The completed "Retirement Allowance Verification Form" with page 3 completed and signed and your physician's signature on page 4.
- 3. The completed "Retirement Verification Form" with page 3 completed and signed and an attestation by a Notary on page 4.

One place you can get these forms notarized is at a UPS store.

CO PAYS ON SENIOR CARE

The New York State Supreme Court issued a preliminary injunction on the \$15. copayment that began on January 1, 2022, by GHI/ Emblem Health. This is pending further hearings before the court. Letters were sent out by Emblem Health stating that "beginning on Jan.12, 2023 and until further notice you will not be required to pay a \$15. co-pay when you get health services." Some members have called GHI/Emblem Health at 800-624-2414 and requested new cards showing a zero co-pay.

UPDATE ON THE CITY OF NEW YORK AETNA MEDICARE ADVANTAGE PPO PLAN FOR MEDICARE ELIGIBLE MUNICIPAL RETIREES

On March 9th you received an eblast from CSA President Henry Rubio indicating that CSA voted "no" on the ratification of an agreement with the city and Aetna to transition Medicare eligible retirees to a Medicare Advantage Plan. However, the Municipal Labor Committee, the umbrella organization representing over 100 city labor unions, voted to approve the plan. The city has indicated that they will move ahead with eliminating all other health insurance options for Medicare eligible retirees other than HIP VIP.

On March 8th CSA held a zoom meeting with representatives from Aetna to explain

- the new plan. On March 7th you received an eblast from CSA with a link to click and find out more information about the Aetna plan. Listed below are some highlights of the City of New York Aetna Medicare Advantage PPO Plan:
- 95 percent of providers are either in-network or accept the Aetna Plan on an out of network basis if they are Medicare doctors. 98 percent of the acute care hospitals in New York State are in network and all out of network hospitals are known to accept the Aetna Medicare Advantage Plan.
- -Memorial Sloan Kettering and HSS are in network .
- -The Aetna annual deductible is \$150. and is guaranteed until 2029. The current Medicare plus Senior Care deductible is \$276.
- Routine podiatry (non-Medicare covered) such as cutting nails is covered. -6-
- -No prior authorization required for MRI's, CT scans, PET Scans, diagnostic cardiology, sleep study, pain management and radiation therapy. Most prior authorizations have been removed.
- -Prior authorization is required for acute in patient, long-term acute care, acute physical rehabilitation, residential behavioral health/substance abuse treatment, skilled nursing, transplant, and home care services. It is also required for services that could be considered experimental and investigational, cosmetic services, specialty medications and new drugs, therapies, procedures, services, and technologies covered by Medicare.
- The Aetna Medicare Rx prescription plan will be administered by Silver Script. The premium for the drug plan will be \$103.50. All Part D drugs are covered.

 -FOR MEMBERS IN OTHER CITY HEALTH PLANS 9/1/23 IS THE

EFFECTIVE DATE for the AETNA MEDICARE ADVANTAGE PPO PLAN.

AS WELL AS AETNA SILVER SCRIPT Rx PLAN.



- -The City will keep HIP VIP Medicare Plan as an option.
- For Family Coverage, Medicare eligible members will automatically be enrolled in the Aetna Medicare PPO Plan. Non-Medicare family members will remain covered under GHI-CBP/EBCBS. Non -Medicare family members enrolled in other non-Medicare plans will be moved to the GHI-CBP/EBCBS plan.
- -To opt out of this plan you must do so between May 1st and June 30, 2023.
- -You can opt out and join HIP VIP.
- -Your only other choice at the present time is to opt out of the City Health Plan and find supplemental coverage including drug coverage on your own. By doing so you will no longer be eligible for Medicare Part B reimbursements and IRMAA. If you opt out you will be eligible to re-enroll during the City's Annual Transfer Period, which occurs every November, unless you have a qualifying event, or use your "Retiree Once in a Lifetime "option.

More information will be coming from Aetna as well as from the CSA. Aetna is doing outreach to educate doctors about the new plan.
